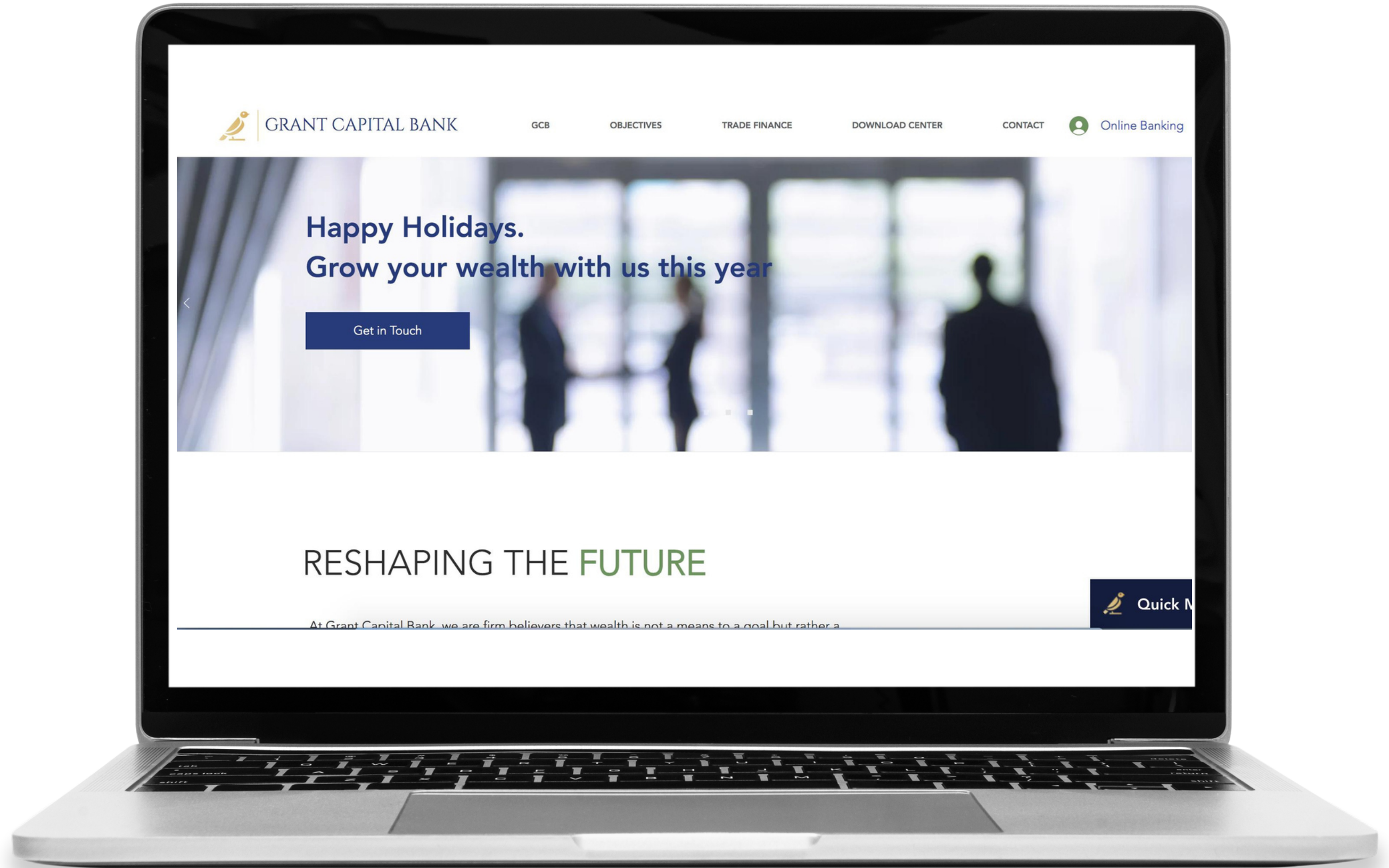

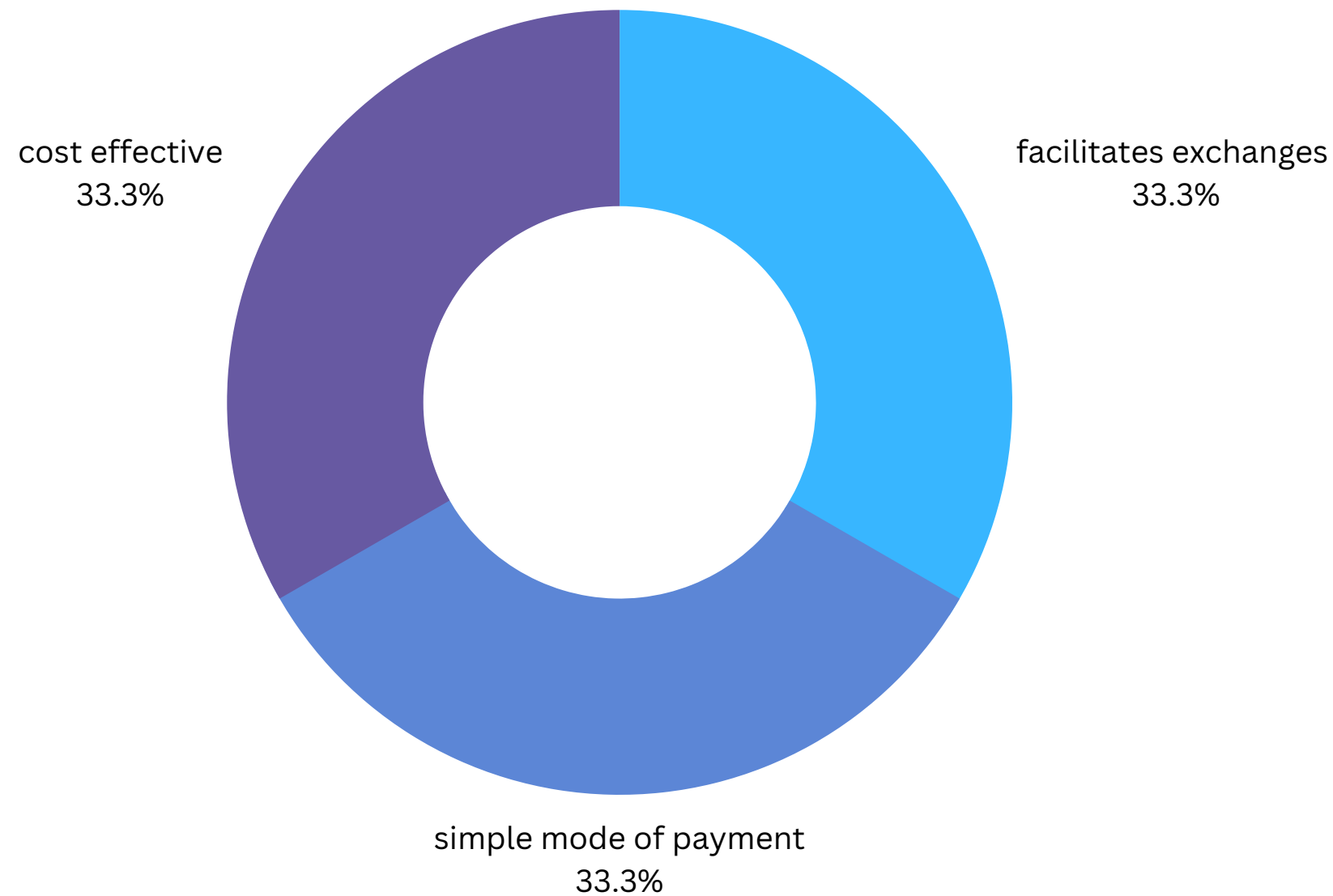

A Bank Guarantee (BG) and a Standby Letter of Credit (SBLC) act as a payment guarantee which generally issued by a bank “the issuing bank” on behalf of client “the applicant” securing to a third party “the beneficiary” in the event the buyer fail to fulfill a contractual commitment, the issuing bank will release the payment to the seller.
